

ROCKING K SOUTH MASTER ASSOCIATION APPLICATION FOR USE OF COMMON AREA AMENITIES

Purpose – The purpose of this schedule is to provide uniform use of Rocking K South Master Association Amenities for owners within the community. The owner must be in good standing with the Association, i.e. all HOA assessments current and not be in collections or in collections with an attorney.

Note: All other spaces not mentioned specifically in this application are a first come first serve basis for owners/residents of the community.

- No music bands, loud music, or any other activity that would disrupt other patron's peaceful enjoyment of the park.
- No weddings, professional parties, or company parties will be permitted.
- **No alcoholic beverages permitted.**
- Animals must be on leashes at all times and owners MUST clean up after their pets.
- Usage times, whether two- or four-hour increments are inclusive of set up and clean up. Please be considerate of the next group who has made a reservation and leave the area promptly. The rental hours are dawn to dusk OR 7:00am – 6:00pm
- The fees for each area are listed with the reservation's times. Payment is required fourteen (14) calendar days prior to the event. Amenities are considered reserved after payment in full is received and the registration process is complete.
- There is a \$50.00 refundable deposit due at the time the reservation is made for the use of the Ramadas, Multipurpose Field, Basketball and Pickleball Courts. In the event the area(s) is/are not returned to its original condition, the deposit will not be refunded.
- An additional \$25.00 will be charged for returned checks (NSF)
- **You may cancel your reservation up to 14 calendar days in advance of the date of the reservation, by written notice to the association. If the association receives the notice at least 14 calendar days in advance of the event, then the Association will issue a full refund to the undersigned.**
- No refunds will be given if the reservation is cancelled after 14 calendar days or as a result of a no show.
- Please allow up to 30 calendar days for refunds and return of security deposits.
- The Association, through its managing agent or representatives, reserves the right to ask any group or individual to leave.
- The attached indemnity agreement must be included with your application.
- Reservations can be made no more than 6 months in advance.
- A photo ID is required to secure a reservation.
- Outside vendors are not permitted at the Basketball or Pickleball Courts.
- For Ramadas: Any outside vendors, i.e., bounce houses, music, entertainment (magician, clowns, etc.) must have a certificate of insurance filed with the Association Office prior to event.
