Exterior Modifications:

Before making **any changes** to the exterior of your home or property, please be aware that **prior approval** is required. This applies to modifications in both the **front and rear yards**. Examples of front yard changes include, but are not limited to, paver additions, driveway extensions, security doors, solar panels or screens, and landscaping. Rear yard modifications may include, but are not limited to, pavers, turf, decorative rock, gazebos, play structures, landscaping, and sun shades. To help preserve property values and maintain consistency throughout the community, all homeowners must submit an application to the Architectural Review and Landscape Committee (ALRC) before beginning any exterior work.
